- 1. Indications:** vitamin D3 helps to maintain healthy bones and muscle function. Willow extract relieves tension and aids joint function.
- 2. Active ingredients:**
 - **Vitamin D3 (Colecalciferol)** coealciferol is a form of vitamin D (D3). It is produced by the skin when exposed to sunlight, especially ultraviolet radiation (UVB). Only 10% is absorbed from food. The foods richest in vitamin D are oily fish such as salmon, eggs, cod liver oil, red meat and some vegetables. Vitamin D3 helps to maintain healthy bones and muscle function.
 - **Willow (Salix alba L.)** the willow bark extract contains flavonoids, tannins and salicin, which help to relieve tension.
 - **Curcuminoids (Curcuma longa L.)** acts as an antioxidant and helps to support joint function.
 - **Piperine (Piper nigrum L.)** acts as an antioxidant and helps to regulate cardiovascular function.

- 6. How to use:** from 1 to 4 tablets per day, as needed, take with water. We recommend using in combination with our **dermocosmetic Skinius[®] Anti-aging Line**.
- 7. Warnings:** do not exceed the daily-recommended dose. Food supplements do not replace a varied, well balanced diet or a healthy lifestyle. Keep out of reach of children under 3 years. If taking antiplatelet or anticoagulant medication, consult a doctor before use.
