**CELLULIS.IN[®] Food supplement
based on Centella extract, Rusco and bitter Orang**

1. Indications: centella extract tackles the blemishes caused by cellulite and, along with butcher's broom, encourages the correct functioning of the microcirculation. Immature bitter orange promotes metabolic activity and weight balance.

2. Active ingredients:

- **Centella (Centella asiatica L. Urb.)** Centella leaves contain flavonoids, tannins and a series of pentacyclic triterpenoids usually called centelloidi. Centelloidi are produced as secondary metabolites. The leaves extract keeps all plant properties and is recommended for cellulite imperfections and promotes microcirculation functionality (useful for tired and heavy legs).
- **Rusco (Ruscus aculeatus L.)** Rusco rhizomes are rich in ruscogenins and flavonoids. The extract obtained from rhizomes is useful to promote microcirculation functionality (useful for tired and heavy legs) and that of vein circulation.
- **Bitter orange (Citrus aurantium L. spp. amara Engl.)** The unripe fruits of bitter orange contain synephrine useful for metabolic stimulation, above all stimulation of the lipid metabolism.

TIT. 10% RUSCOGENINA, ARANCIO AMARO (CITRUS AURANTIUM L. SSP. AMARA ENGL., FRUTTO IMMATURO) E.S. TIT. AL 6% IN SINEFRINA; STABILIZZANTE: CARBOSSIMETILCELLULOSA SODICA RETICOLATA; AGENTI DI RIVESTIMENTO: IDROSSI-PROPIL-METILCELLULOSA, TALCO, POLIETILGLICOLE; AGENTI ANTIAGGLOMERANTI: SALI DI MAGNESIO DEGLI ACIDI GRASSI, BISSIDO DI SILICIO; COLORANTI: CARBONATO DI CALCIO, COMPLESSI DELLE CLOROFILLE E DELLE CLOROFILLINE CON RAME.
