PLUSOL.IN[®] Food supplement
based on Copper, maritime Pine extract and Zeaxanthin

1. Indications: copper is indicated to favor the normal skin pigmentation and protect cells from oxidative stress. Maritime pine extract acts as an antioxidant.

2. Active ingredients:

- **Copper** is a mineral implicated in several biochemical processes. It is linked to specific metal-proteins and is an enzyme cofactor. Thanks to its redox potential it contributes to cell protection from oxidative stress, helps the immune system, contributes to the normal energetic metabolism, maintenance of normal connective tissue, transport of iron in the body and promotes skin pigmentation being the tyrosinase cofactor, which is the enzyme involved in the synthesis of melanin.
- **French maritime Pine (Pinus pinaster Ait.)** is rich in oligomeric flavonoids belonging to the group of proanthocyanidins (OPC), a category of polyphenols highly represented in the botanic world due to their chemical and physical structure. Maritime pine bark extract acts as an antioxidant thanks to its components.
- **Zeaxanthin from Tagetes erecta (Tagetes erecta L.)** presents in tagetes erecta, is a carotenoid of the xanthophylls group that contributes to the antioxidant action.

TIT. 50% IN PROANTOCIANIDINE (OPC); AGENTI DI RIVESTIMENTO: AMIDO ACETILATO, TALCO; STABILIZZANTE: CARBOSSIMETILCELLULOSA SODICA RETICOLATA; COLORANTE: CALCIO CARBONATO; AGENTI DI RIVESTIMENTO: GLICEROLO, GOMMALACCA; AGENTI ANTIAGGLOMERANTI: SALI DI MAGNESIO DEGLI ACIDI GRASSI, BISSIDO DI SILICE; RAME CITRATO, COLORANTE: OSSIDI DI FERRO GIALLO.

8. Shelf life: 36 months.
