NOAGY[®] LIP BALM
Anti-Aging Regenerating

1. **Indications:** a nourishing regenerating formula with effective anti-aging action. It plumps lips and reduces micro-wrinkles in the lip contour area. Ideal for daily hydration. Contains a sun screen filter.
2. **NOAGY[®]** contains *Fosfidina* a complex of phospholipids extracted from soy and glucosamine. Their synergistic produces a regenerating action on cutaneous tissue since glucosamine, a precursor of hyaluronic acid, is carried by the phospholipids through to the dermis where it can act effectively.

Active ingredients:

- **Phospholipids** and **Glucosamine:** offer superficial and deep hydration of the epidermis.
 - **Boswellia** and **Beta-Glucan:** maintain plump lips for overall rejuvenation.
 - **Ceramides:** improve hydration and elasticity.
 - **Hyaluronic Acid microspheres:** help keeps lips soft and smooth.

 4. **Ingredients:** DIMETHICONE, ISODODECANE, CERA ALBA, DIMETHICONE CROSSPOLYMER, HYDROGENATED POLYISOBUTENE, VP/HEXADECENE COPOLYMER, ETHYLHEXYL METHOXYCINNAMATE, DIMETHICONOL, OCTYLDODECANOL, LECITHIN, GLUCOSAMINE SULFATE, BOSWELLIA SERRATA RESIN EXTRACT, BETA-GLUCAN, SODIUM HYALURONATE, PHYTOSPHINGOSINE, CERAMIDE NP, CERAMIDE AP, CERAMIDE EOP, SUPEROXIDE DISMUTASE, TOCOPHERYL ACETATE, ASCORBYL TETRAISOPALMITATE, HYDROLYZED RICE PROTEIN, GLYCINE SOJA PROTEIN, SODIUM DEXTRAN SULFATE, AQUA, GLUCONOLACTONE, CALCIUM GLUCONATE, XANTHAN GUM, ETHYL VANILLIN, GLYCERIN, SODIUM BENZOATE, POTASSIUM SORBATE, ETHYLHEXYLGLYCERIN, ETHYLHEXYL PALMITATE, CAPRYLYL GLYCOL, SILICA DIMETHYL SILYLATE, CHOLESTEROL, BENZYL ALCOHOL, SODIUM LAUROYL LACTYLATE, BUTYL METHOXYDIBENZOYLMETHANE, PROPYLENE GLYCOL, ALCOHOL, BUTYLENE GLYCOL, AROMA, HEXYLENE GLYCOL, CARBOMER, BHT, PHENOXYETHANOL
 5. **Cosmetic form:** balm
 6. **Capacity:** 15ml jar / 5ml tube – travel size
 7. **How to use:** apply to lips and lip contour area and lightly pat in with ring finger.
 8. **Warnings:** NOAGY[®] lip balm has been dermatologically tested on sensitive skin. Use not recommended in case of allergy to any of the components.
 9. **PaO (period after opening):** 12 months
 10. **Storage:** the product should be stored at normal ambient conditions (in a dry place and at room temperature) and protected from light.
