RIMAGE® EYE CONTOUR GEL CREAM
Regenerating Anti-Aging

1. **Indications:** regenerating and anti-aging treatment for the eye contour area, ideal for preventing and reducing wrinkles, micro-wrinkles, dark circles, puffy eyes and sagging eyelids. Deeply hydrates and nourishes the eye contour area for more rested and younger looking skin. Fresh and light texture.
2. **RIMAGE®** gel cream contains *Fospidina*, a complex compounded by phospholipids extracted from soy and glucosamine. Their synergistic produces a regenerating action on the skin tissue since the activity of glucosamine, a precursor of hyaluronic acid, turns out to be effective thanks to the conveyance carried out by phospholipids that penetrate up to the dermis. Fresh and light texture.

Functional active ingredients:

- **High, medium and low molecular weight Hyaluronic Acid:** firming, elasticizing and toning action for smoother and tighter skin.
- **Hesperidin:** flavonoid present in citrus fruits useful to promote microcirculation and to prevent and improve dark circles, bags and sagging eyelids.
- **Lactoferrin:** promotes the removal of iron ions responsible for the brownish colour of dark circles.

4. **Ingredients:** AQUA, CAPRYLIC/CAPRIC TRIGLYCERIDE, PROPYLHEPTYL CAPRYLATE, GLYCERIN, ORYZA SATIVA STARCH, SODIUM POLYACRYLATE, LECITHIN, GLUCOSAMINE SULFATE, LACTOFERRIN, GLUCOSYL HESPERIDIN, SODIUM HYALURONATE, TOCOPHEROL, HYDROXYPROPYL GUAR, ETHYLHEXYLGLYCERIN, ASCORBYL PALMITATE, CITRIC ACID, PHENOXYETHANOL, DISODIUM EDTA

5. **Cosmetic form:** gel cream

6. **Capacity:** 15ml flacon airless.

7. **How to use:** apply to eye contour area morning and/or evening. Use index and middle fingers to gently pat the gel cream from the temples to the bridge of the nose and the upper eyelid.

8. **Warnings:** RIMAGE® eye contour gel cream has been dermatologically tested on sensitive skin. Use not recommended in case of allergy to any of the components.

9. **PaO (period after opening):** 6 months

10. **Storage:** the product must be stored under normal ambient conditions (in a dry place, at room temperature) protected from light.
